EXTENSION OF THE DRIVING LICENCE

It can be applied in the three months prior to the end of its validity at the Drivers Check Centre or at the Provincial Traffic Departments. Where appropriate, the extension of the licence can also be applied from abroad.

AT THE DRIVERS CHECK CENTRES

1st. PROOF OF IDENTITY AND RESIDENCE:

- **ID Card or PASSPORT:** valid and original
- **AUTHORISATION FOR RESIDENCE or IDENTITY DOCUMENT of the country of origin or PASSPORT together with the CERTIFICATE OF INSCRIPTION IN THE ALIENS' CENTRAL REGISTER** for EU foreign nationals: original and valid.
- **AUTHORIZATION OF RESIDENCE** for non-EU nationals: original and valid.

2nd. A MEDICAL EXAMINATION - APTITUDE TEST - WILL BE SENT ONLINE.

3rd FEE IV.3 : 24,10 €

At the Centre, a photograph of yours will be taken and you must sign the application for an extension of the licence.

AT THE PROVINCIAL TRAFFIC DEPARTMENTS

1st. OFFICIAL FORM available at Traffic Departments and on DGT's website (www.dgt.es).

2nd. FEE IV.3 : € 24,10 (means of payment at the back of the informative sheet)

3rd. PROOF OF IDENTITY AND RESIDENCE:

- **ID Card or PASSPORT:** valid and original
- **AUTHORISATION FOR RESIDENCE or IDENTITY DOCUMENT of the country of origin or PASSPORT together with the CERTIFICATE OF INSCRIPTION IN THE ALIENS' CENTRAL REGISTER** for EU foreign nationals: original and valid.
- **AUTHORIZATION OF RESIDENCE** for non-EU nationals: original and valid.

4th. ELECTRONIC PSYCHOPHYSICAL APTITUDE REPORT entered in the Register of Drivers by a DRIVERS CHECK CENTRE

5th. **PHOTOGRAPH:** an original 32 x 26 mm photograph in colour and taken against a plain background, facing forward without anything covering the head, without sunglasses or tinted glasses or any other item which may prevent or make the identification of the person problematic.

Veils may be acceptable in photographs of applicants who, for religious purposes, wear a head covering that obscures their hair, with the only limitation that their full face must be visible from the hairline to the bottom of the chin so as not to prevent or make the identification of the person problematic.

6th. TALÓN FOTO: completed and signed within the appropriate box.

FROM ABROAD

The applications shall be processed through the diplomatic or consular representations and the following documents shall be produced:

- **COPY OF PROOF OF PAYMENT OF THE FEE IV.3 : 24,10 €**

The payment will be made by bank transfer FOR THE EXACT AMOUNT in euros to the DGT:

The applicant shall bear the cost of the transfer; the following details must be included and in this order:
1st. DNI (ID card number); 2nd. Surname and name; 3rd. Fee to renew the driving licence.

- **PSYCHO-PHYSICAL APTITUDE REPORT** issued by a doctor of the country where the applicant resides approved by the Spanish Diplomatic Mission or Consular Office in that country with a recent photograph of the applicant. This report shall attest the aptitude to drive.
- **TALÓN FOTO:** duly completed and signed within the appropriate box (**SEE THE BACK**)

SPECIAL CASES

ADDRESS: If your address changes, please communicate the new address.

*The submission of documentation supporting **the registration data (address) and IAE (trade tax)** may be replaced by an express authorization so that the Directorate General for Traffic can verify such information by telematic means. For that purpose, the applicant must tick the appropriate box in the application form or fill in the express consent form available at the DGT's website or at the Traffic Departments. If DGT does not receive valid information, the applicant must submit documentation in order to remedy this situation*

FEE: A) People over 70 years old do not have to pay the fee.
B) When for medical reasons the extension is for a shorter period of time laid time by law, the amounts of the fees shall be as follows:

Up to 4 years	€ 19,30
Up to 3 years	€1450
Up to 2 years	€970
1 year or less	€ 490

MEANS OF PAYMENT OF FEES: Three means of payment:

- by bank card or direct debit from a bank account online on www.dgt.es
- by a bank card at Traffic Departments and
- by direct debit from a bank account or in cash (model form 791 available at Traffic Departments and on www.dgt.es)
