REGISTRATION OF HISTORIC VEHICLES

IMPORTANT: You must book an appointment before conducting any formalities at any Provincial Traffic Department.

NOTA INFORMATIVA

- **Official application form.** (*Available on www.dgt.es*)
- **Fee** of €97.80, except mopeds €27.30. (Payment in cash is not accepted).
- **Identification of the applicant:**
 - Natural persons: official document accrediting his/her identity and address (ID card, Spanish driving licence, residence card, Passport plus the Foreigner Identification Number)
 - Legal persons: tax identification card of the company accrediting the representation and identity of the person who signs the application (*Available on www.dgt.es*)
 - Minors or disabled persons: data and signature of the father, mother or guardian, his/her ID card and document accrediting their relationship.
- **Decision** by the competent body of the Autonomous Region in which the vehicle is classified as "historic".
- **Vehicle documentation:**
 - Roadworthiness certificate attesting that the vehicle is registered as a historic vehicle.
 - Four colour photographs of the vehicle (the two sides, the front and rear of the vehicle).
 - Registration certificate and roadworthiness certificate (original and photocopy), if the vehicle is in use.
 - Documentation of the foreign vehicle (original and photocopy), if the vehicle is from a foreign country.
- **Accreditation of the ownership of the vehicle** in the event that the person who registers the vehicle is not the same person appearing in the original documentation by means of one of the following: *a notarial document*: act of notoriety or declaration; *Purchase invoice* if it is purchased in a car dealer or to a legal person. If the vehicle is from the EU or a third country and if the invoice is from a Spanish car dealer, the applicant shall present the IAE (Trade Tax) or a document declaring that he/she is included in the VAT registered traders for intra-community transactions; *Purchase agreement* if the sale is between individuals.
- **Certificate of transport:** in case of a bus or a vehicle for transporting goods with a MAM above 6 tonnes and a load capacity exceeding 3.5 tonnes, unless they have been registered online in the DGT Register of Vehicles.
- **Taxes:**
 - Proof of payment or exemption from the municipal vehicle tax where the applicant resides (*original or photocopy*).
 - Proof of payment /exemption /non-liability to the Special Tax on Certain Means of Transport (model 576, 06 or 05 from the Agencia Estatal Tributaria –Agency of the Tax Authorities-, www.aeat.es), if the vehicle has not been previously registered in Spain.
 - Proof of payment or exemption of the Tax on capital transfers (if a contract between two private persons or a notarial document is presented).
- A Single Administrative Document issued by the Customs Office in the event of an imported vehicle from a third country.

NOTE: *If the holder does not submit the documents, it will be necessary to also submit a written authorization signed by him/her, together with his/her original ID card, specifying that this representation is free of charge (model available on www.dgt.es).*

If any of the data required above cannot be clearly proven, additional documentation could be requested.
